

Synopsis of Confidential Escrow Agreement
XTRAORDINARY ADVENTURES, LLC

To insure the security and proper handling of all deposited funds remitted pursuant to the terms and conditions set forth in the attached **ROCKETSHIP TOURS Participant Agreement, XTRAORDINARY ADVENTURES, LLC**, a Florida Limited Liability Company located at 9070 Kimberly Blvd, ste #27-101, Boca Raton, Fl 33434, hereafter referred to as '**XA**' as agent of **ROCKETSHIP TOURS**, will place into its established Escrow Account with the J.P. Morgan Chase Bank, located at 386 Park Avenue South New York, NY 10016 and administered under the direction of Want and Ender, P C, accountants for '**XA**', located at 112 Madison Avenue, 5th Fl, New York, NY 10016, all funds received from each Registering Participant, hereafter referred to as '**RP**',

Pursuant to this Escrow Agreement all '**RP**' remittances shall be collected and deposited to '**XTRAORDINARY ADVENTURES Escrow Account**' c/o Want and Ender P C Account #2902460696 ABA # 021000021. The only signatory on this account shall be Martin Ender of Want and Ender, P C. Subsequently, deposits will be forwarded to **ROCKETSHIP TOURS** escrow subject to terms and conditions as set forth from **ROCKETSHIP TOURS** reservation procedures with **XA**.

DEPOSITS:

- a) Each '**RP**' shall either wire or send payment payable to '**XA-Escrow Account**' c/o Want and Ender, P C to register, and is required to remit a minimum deposit of \$20,000.00.

- b) All deposits are non-refundable except subject to terms of **ROCKETSHIP TOURS**.

FINAL PAYMENTS:

- c) Each approved '**RP**' will have 30 days once acceptance notice has been delivered by **ROCKETSHIP TOURS** to make their final payment of \$75,000.00 to '**XA**'. Upon receipt **ROCKETSHIP TOURS** will assign the next number in the queue to the '**RP**'.

TERMINATION:

- d) This applies only through **ROCKETSHIP TOURS**. Conditions can be failure to medically qualify or withdrawl within the terms of the insurance and subject to conditions established by **ROCKETSHIP TOURS**.

ALLOCATION OF FUNDS:

- g) Upon acceptance and clearance of all deposited funds they shall be forwarded on to **ROCKETSHIP TOURS** by Want and Ender, P C to make the necessary disbursements, pursuant to contractual commitments provided. It is also noted that **XTRAORDINARY ADVENTURES, LLC** will be screening all bookings and all necessary contracts for accuracy.

This agreement remains the confidential business of all concerned parties. It is acknowledged that any potential '**RP**' concerned about the validity of the project may inquire of the existence of such agreement, however, any balances or number of '**RP**'s are not to be given to anyone except '**XA**'.
